

USDA Rural Health Liaison

The USDA Rural Health Liaison (RHL) position was created by Congress in the 2018 Farm Bill to enhance USDA's efforts to support rural health. USDA RHL Kellie Kubena cultivates relationships across USDA, with other federal agencies, and with external partners to gather information and resources to promote department-wide efforts to address rural America's health care needs.
