#### USDA-RD

• Contacts Recipient & requests complete application

#### **CPF/CDS RECIPIENT**

• Completes application & submits to USDA-RD

#### USDA-RD

- Obligates grant funds & issues Letter of Conditions
- Disburses funds after project completion




#### **Essential Community Facilities**

- Hospitals, health clinics
- Colleges
- Schools
- Daycares
- Fire houses, first responder vehicles and equipment
- Community centers and more

# **Community Facilities Programs Overview**

- The Community Facilities Program offers fixed rate, low-cost direct loans, loan guarantees and grants to develop or improve essential public services and facilities in communities across rural America.
- These amenities help increase the competitiveness of rural communities in attracting and retaining businesses that provide employment and services for their residents.
- These facilities **improve the basic quality of life** and assist in the development and sustainability of rural America.



# Community Facilities Programs Eligible Uses of Grant Funds

Construct, expand or improve an essential community facility

□Purchase vehicles and major equipment to provide essential services

□Purchase real estate & buildings

□Pay reasonable and necessary fees, when part of a facility, such as:

- Legal
- Architectural and/or Engineering
- Environmental
- Archeological

# **Community Facilities Programs Ineligible Uses of Grant Funds**

□Operating expenses

- □Refinance existing debt
- □Interest expense
- Development or purchase of facilities located in nonrural areas
- Business and industrial buildings in connection with industrial parks
- □Facilities to be used primarily for recreation purposes

□Loan or grant finder's fees

□Pay an amount greater than 75 percent of the project cost

# Environmental Overview National Environmental Policy Act (NEPA)

CPF/CDS projects must meet the requirements of NEPA

CPF/CDS projects must comply with other environmental protection laws

Endangered Species Act

□ National Historic Preservation Act

And more...

□ CPF/CDS Recipients will provide supporting documentation for USDA-RD's review

Construction should not begin until USDA-RD has made its environmental decision

# Planning, Bidding, Contracting, Constructing & Procuring

**USDA-RD** will review the following documents

□ Preliminary Architectural Report (PAR)

□Architect and/or Project Manager agreements

Request to use Design Build or Construction Management Delivery Method

□Bid Documents

Bid Award

□Plans and Specifications

□Contract Document - Review

□Contract Document – Executed Docs

□Construction Phase Documents

- Payment Applications
- Change Orders
- Close-out and Warranty Phase

# **Build America, Buy America Act**

□ Infrastructure Investment and Jobs Act Public Law 117-58

□ Do you have a BABAA covered project?

□ Are you a non-federal entity?

□ Are you financing an infrastructure project?

Does the project include construction, alteration, maintenance, or repair?

You should plan early in the design phase of your project to incorporate products that meet BABAA requirements.





## **Notice of Federal Interest**

A Notice of Federal Interest (NOFI) applies when grant funds are used to purchase real property or appurtenant to real property

#### **NOFI Required**

 Real Estate Purchase
 Real Estate Construction
 Improvements to Real Estate – HVAC, roof, flooring

#### **NOFI Not Required**

- Equipment not affixed Generator, CT scanner
- Telecommunications equipment
  Vehicles
- □ CPF/CDS recipient files the NOFI in the official real property records
- □ CPF/CDS recipient provides evidence of the filing prior to advance of funds
- □ Sale or transfer of property is subject to the interest of USDA-RD

## Disbursements, Reporting & Post Award Requirements

FY24 CPF/CDS

#### **Disbursements**

- Prior to disbursement of funds, the CPF/CDS Recipient must:
  - Meet all conditions of the Letter of Conditions
  - Execute Form RD 3570-3, Community Facilities Grant Agreement
  - Submit a request for funds along with supporting documentation
- Typically, grant funds will be disbursed when needed and all other project funds are expended

#### Reporting

- Performance and Financial Status Report requirements are outlined in the Grant Agreement and occur:
  - Quarterly, Semi-Annually or Annually
  - Final Report 120 days after the performance end date

#### **Post Award Requirements**

- Submit the following reports:
  - Physical inventory of equipment every two years
  - Status of real property annually for 15 years, after 15 years no less than every 5 years
- Request disposition instructions for equipment or real property when no longer needed

Incomplete application documents


Bidding or construction has already begun

#### **Frequently Asked Questions**

- 1. What if a CDS or CPF recipient is not contacted by a Rural Development State Office?
  - Recipients may contact the USDA-RD state office to begin the application submission process. Contact information can be found on the RD website (available at this link: https://www.rd.usda.gov/about-rd/state-offices).
- 2. What if the recipient's project cost has increased since the initial CDS or CPF request?
  - Recipients are responsible for securing additional funds to complete the project or reduce the project scope to stay within budget. Recipients who meet eligibility requirements and have repayment ability can apply for a USDA-RD Community Facilities loan.
- 3. Does the recipient need to be registered with SAM.gov?
  - Yes. Recipients must supply a SAM registration number (instructions are available at this link: <u>https://sam.gov/content/home</u>).
