The firehouse is undersized, and the current location prohibits the unfettered movement of emergency vehicles and equipment. Additionally, the barracks are too small to support the growing department, which provides first responder services to the village of Granville and to Denison University. The department's administrative offices are in a house next to the barracks, are insufficient to meet the township's needs, and are not compliant with the Americans with Disabilities Act. The new location will allow for quicker response times to the 5,646 residents the fire department serves. |

Funds will be used to re-purpose the Springs Student Center to better serve the students and the community. This is Phase II to complement Phase I of the project in which USDA funded \$50.8 million in Fiscal Year 2018. The college currently has 899 students, but enrollment is projected to increase to 1,161 by 2022.
