

Rural Data Gateway: USDA Rural Development's Public-Facing Rural Investments Dashboards

At USDA Rural Development, we understand rural investors, partners, and local officials need accurate data to make informed decisions. Good decision-making helps ensure rural people can thrive in communities where business owners, farmers and ranchers can tap into modern infrastructure, families have access to modern, affordable health care, kids and teachers can use world-class academic resources, and entrepreneurs can find creative funding options.

For these reasons, we're launching a new federal resource – the Rural Data Gateway – to make USDA Rural Development's investment portfolio more open and accessible to its partners and people across rural America. This is one of the many steps we're taking to be a better, more strategic partner with the communities we serve.

The dashboards are presented under four headings: Overview, Program Area, State/County View, and Congressional District View – and reflect loan, grant, and loan guarantee data from fiscal year 2012¹ to the date indicated on the dashboard. The investments support rural communities in the United States and US territories: Puerto Rico, the US Virgin Islands, American Samoa, the Commonwealth of the Northern Mariana Islands, and Guam – as well as in freely associated states: the Federated States of Micronesia, the Republic of the Marshall Islands, and the Republic of Palau.

About the Data

Update Frequency: Dashboards are updated weekly and include all publicly-announced investments.

Data Subject to Change: Dashboards represent active financial data that can change with project status. For example, a project might be canceled, or its funding might be adjusted. Dashboards reflect these changes monthly and therefore, cannot be considered static investment snapshots.

¹ The fiscal year begins on October 1 of each year and ends on September 30 of the following year.

Personally Identifiable Information: To ensure the privacy of RD loan and grant recipients, Personally Identifiable Information (PII) is not included. We comply with federal standards to protect PII and prevent identities from being directly or indirectly inferred. For this reason, data regarding Single Family Housing loan and grant programs and Multifamily Housing Rental Assistance and Tenant Voucher programs are aggregated at the county level.

Project Location: A project's location typically reflects where the project work is being done. In some instances, this will be the main facility within a utility, a business headquarters, or an area that does not reflect the entire community being served. For example, the project location for a rural hospital might specify one county even though the hospital serves residents of multiple counties.

Electric and Telecommunications Programs: Electric and Telecommunications programs data are displayed in the Program Area dashboards, but not in the State/County View or Congressional District View dashboards. This is because Electric and Telecommunications program investments often reflect facilities that serve multiple counties, districts, or in some cases, states. These service areas cannot be assigned a specific geography on the dashboards. Intermediary Programs: We administer programs known as “intermediary programs” by partnering with third parties – such as nonprofits or Tribal organizations – that re-lend funds or provide technical assistance to rural people and entrepreneurs. These programs typically serve multiple counties and congressional districts. Therefore, the project locations for intermediary programs reflect the address of the lender or technical assistance provider. Intermediary programs include:

Program Data Exclusions: The information in the dashboards represents about 99 percent of the total dollar amount of USDA-RD investments during the specified period. Regular reconciliation and data check processes help us ensure accuracy. However, the timing of reporting sometimes is adjusted for congressional release, or in coordination with other USDA agencies. In other instances, investment information data is not available for dashboard release because of operational and timing considerations that make weekly reporting unachievable.
