What does this program do?

Calendar Year 2022 Disaster
Circuit Rider Technical
Assistance Grants provide
funding to qualified organizations
that offer onsite technical
assistance to communities
impacted by events resulting in
CY22 Presidentially Declared
disasters.

For the purposes of this grant, the term "water" is inclusive of all water resource infrastructure, including drinking water, wastewater, storm drainage, and solid waste facilities.

Who can apply?

- Municipalities, counties, districts, authorities, or other political subdivisions of a state, commonwealth, or territory
- · Nonprofit organizations
- Federally recognized Tribes

What is an eligible area?

- Rural areas and towns with populations of not more than 35,000
- · Federally recognized Tribal lands
- Colonias

Areas in the following states and territories experienced qualifying events in calendar year 2022: Alaska, American Samoa, Arizona, California, Colorado, Florida, Idaho, Illinois, Kansas, Kentucky, Maine, Massachusetts, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Mexico, New York, North Carolina, North Dakota, Oklahoma, Oregon, Puerto Rico, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, U.S. Virgin Islands, Vermont, Virginia, Washington, and West Virginia.

How can funds be used?

Among other things, CY 22 Disaster Circuit Rider Technical Assistance grant funds can be used to:

 Support short-term disaster assistance and troubleshooting

- Identify and evaluate long-term solutions with support of such things as risk and resilience assessments and emergency response plans
- Provide training and other resources to operators and management
- Develop applications for USDA RD funding, including feasibility studies or engineering and environmental reports
