



## **Data Collection System (DCS) Information Page**

All RUS year-end financial and operating reports for Electric Borrowers and Telecommunications Borrowers that file annually are due by March 31, of the following year. All Telecommunications Borrowers that file quarterly reports must submit their quarterly reports no later than 30 days after the end of each quarter.

### **eAuthentication**

Borrowers may now use email to transmit to RUS certain requests and signed forms, in portable document format (pdf), including the Form 674 (Certificate of Authority to submit or grant access to data) and Board Resolution.

- Staff with "Certifier" or "Admin" roles need to submit a new Form 674 and Board Resolution to their GFR's.
- Staff with "User" or "Reader" roles should contact their DCS Administrator at their company to have their previously assigned eAuth ID made inactive and add in their new eAuth ID with the appropriate role.
